The request of PanAmSat Licensee Corp. (PanAmSat), IBFS File No.

SAT-MOD-20080811-00153, IS GRANTED. Accordingly, PanAmSat IS AUTHORIZED to operate its C- and Ku-band Fixed Satellite Service (FSS) space station, Intelsat 2 (Call Sign S2459), at the 169.10° E.L. orbital location using the 3700-4200 MHz (space-to-Earth), 5925-6425 MHz (Earth-to-space), 12.25-12.75 GHz (space-to-Earth), and 14.0-14.5 GHz (Earth-to-space) frequency bands. These operations are authorized in accordance with the technical specifications set forth in the application, the Federal Communications Commission's rules, and the following conditions:

1. PanAmSat's request for a waiver of Section 25.114(d)(3) of the Commission's rules, 47 C.F.R. § 25.114(d)(3), IS GRANTED. Section 25.114(d)(3) requires predicted space station antenna gain contour(s) for each transmit and each receive antenna beam and nominal orbital location requested. The main purpose of the contour map is to allow evaluation of the potential for harmful interference with other operators and services in the frequency band. See SES Americom, Inc., Application for Modification of Space Station Authorization, DA 04-1581, *Order and Authorization*, 19 FCC Rcd. 20,377, 20,377-78 (paras. 4-8) (Int'l Bur., Sat. Div. 2004). PanAmSat's application indicates that the TT&C Bi-cone and wide coverage antenna diagrams (Exhibits 2T, 2U, 2P, 2R, 2Q and 2S) were not prepared in accordance with the requirements in Section 25.114(d)(3) of the Commission's rules because the space station manufacturer did not provide contours in the required form. We find that Exhibits 2T, 2U, 2P, 2R, 2Q and 2S, together with the descriptive characterization provided in Section 2 of the application, provide a sufficiently complete description of the transponder characteristics of the Intelsat 2 space station to enable the Commission to determine whether or not the Intelsat 2 space station meets the Commission's technical requirements.

2. While at the 169.10° W.L. orbital location, PanAmSat shall maintain the Intelsat 2 space station with an east/west longitudinal station-keeping tolerance of 0.05 degrees.

3. PanAmSat is afforded thirty days from the date of release of this grant and authorization to decline this authorization as conditioned. Failure to respond within this period will constitute formal acceptance of the authorization as conditioned.

4. This action is issued pursuant to Section 0.261 of the Commission's rules on delegated authority, 47 C.F.R. § 0.261, and is effective immediately. Petitions for reconsideration under Section 1.106 or applications for review under Section 1.115 of the Commission's rules, 47 C.F.R. §§ 1.106, 1.115, may be filed within 30 days of the date of the public notice indicating that this action was taken.




