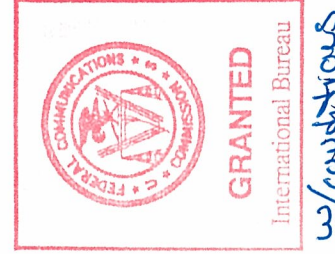

Intelsat North America LLC's (Intelsat) request to modify its authority in order to operate its C- and Ku-band satellite, Galaxy 25 (Call Sign: S2154), at the 93.1° W.L. orbital location, IBFS File No. SAT-MOD-20080825-00159 (Call Sign S2154), IS GRANTED.¹ Accordingly, Intelsat North America (Intelsat) is authorized to provide Fixed Satellite Services (FSS) in the 3700-4200 MHz (space-to-Earth), 5925-6425 MHz (Earth-to-space), 11.7 to 12.2 GHz (space-to-Earth), and 14.0-14.5 GHz (Earth-to-space) frequency bands using the Galaxy 25 space station at the 93.1° W.L. orbital location. These operations are authorized in accordance with the technical specifications set forth in the application, this Attachment, and the Commission's Rules and subject to the following conditions:

1. Intelsat shall operate the Galaxy 25 satellite at the 93.1° W.L. orbital location in compliance with all existing or future coordination agreements for that location.
2. While at the 93.1° W.L. orbital location, Intelsat shall maintain the Galaxy 25 spacecraft with an east/west longitudinal station-keeping tolerance of 0.05 degrees.
3. IBFS File No. SAT-STA-20081111-00214 IS DISMISSED as MOOT.
4. Grant of this modification application does not change the expiration date of the authorization for Galaxy 25: June 30, 2012.
5. Intelsat is afforded thirty days from the date of release of this grant and authorization to decline this authorization as conditioned. Failure to respond within this period will constitute formal acceptance of the authorization as conditioned.
6. This action is issued pursuant to Section 0.261 of the Commission's rules on delegated authority, 47 C.F.R. § 0.261, and is effective immediately. Petitions for reconsideration under Section 1.106 or applications for review under Section 1.115 of the Commission's rules, 47 C.F.R. §§ 1.106, 1.115, may be filed within 30 days of the date of the public notice indicating that this action was taken.

¹ Intelsat was previously authorized to operate Galaxy 25 at the 76.70° W.L. orbital location. File No. SAT-AMD-20060803-00084, Grant Stamp (with conditions) (Dec. 1, 2006). Intelsat, however, never relocated Galaxy 25 to the 76.70° W.L. orbital location. Accordingly, grant of authority to operate the Galaxy 25 satellite at the 93.1° W.L. orbital location supersedes the previous authorization to operate the Galaxy 25 satellite at the 76.70° W.L. orbital location.
