The request of EchoStar Satellite Operating L.L.C. (EchoStar) to modify the assigned orbital location of its Direct Broadcast Satellite (DBS) space station, EchoStar-5 (Call Sign S2658), from the 148° W.L. orbital location to the 147.925° W.L. orbital location is GRANTED. Accordingly, EchoStar is authorized to operate the EchoStar-5 space station using DBS channels 1-32 in the 12.2-12.7 GHz (space-to-Earth) and 17.3-17.8 GHz (Earth-to-space) frequency bands at the 147.925° W.L. orbital location. This authorization is subject to the conditions and technical specifications set forth in its application, this attachment, and the Federal Communication Commission's rules.

1. All of the originally authorized terms, conditions, and technical specifications of the EchoStar-5 space station authorization (File No. SAT-A/O-20081003-00215), except for the authorized orbital location, remain in effect.
2. EchoStar must maintain the EchoStar-5 space station at the 147.925° W.L. orbital location with a  $\pm 0.05$  degree longitudinal station-keeping tolerance. EchoStar shall not operate the EchoStar 5 space station outside of these station-keeping limits without further authorization.
3. EchoStar is afforded 30 days from the date of the release of this authorization to decline it, as conditioned. Failure to respond within this period will constitute formal acceptance of the authorization, as conditioned.
4. This action is issued pursuant to Section 0.261 of the Commission's rules on delegated authority, 47 C.F.R. § 0.261, and is effective immediately. Petitions for reconsideration under Section 1.106 or applications for review under Section 1.115 of the Commission's rules, 47 C.F.R. 1.106, 1.115, may be filed within 30 days of the date of the public notice indicating that this action was taken.
