Description of Application

SkyTerra Subsidiary LLC (“SkyTerra”) hereby files this application to modify the license for SkyTerra 1 to add the Geostationary Mobile Satellite Adaptation (“GMSA”) and Geostationary Mobile Radio-3G (“GMR-3G”) air interface protocols to its authorized satellite at 101.3°W.¹ SkyTerra 1 is a next-generation L-band Mobile Satellite Service (“MSS”) satellite with associated feeder links in the Appendix 30B Ku band.

Provided in the Technical Appendix are the principal service link transmission characteristics (Table A), the communications subsystem characteristics (Table B), a Power Flux Density (“PFD”) compliance demonstration (Tables C-1 to C-2), the forward and return link budgets (Tables D-1 to D-16), and a two-degree spacing analysis for SkyTerra 1 using GMSA and GMR-3G air interface protocols. An updated, comprehensive Schedule S attachment, reflecting these changes, is also provided with this modification application.² All other system information, parameters and analyses, including waiver requests, previously approved by the FCC are not changed by this application.³ Grant of this application will enable SkyTerra to deploy service using additional air interface protocols, creating flexibility for SkyTerra to use a number of different mass market wireless standards to satisfy customer requirements and preferences.⁴
