The application of DISH Operating L.L.C. (DISH) to modify its authorization for its Direct Broadcast Satellite (DBS) service EchoStar 10 space station (Call Sign S2694) at the 110.2° W.L. orbital location, IBFS File No. SAT-MOD-20090909-00095, to include authority to operate beams R10 and T48, IS GRANTED.<sup>1</sup> Operations under this authorization must be in accordance with the terms, conditions, and technical specifications set forth in DISH's application and the Federal Communication Commission's rules, and are subject to the following conditions:

1. In connection with the provision of service in any particular country, DISH is obliged to comply with the applicable laws, regulations, rules, and licensing procedures of that country.
2. DISH shall operate beams R10 and T48 subject to the conditions and waivers set forth in the authorization of the EchoStar 10 space station. IBFS File Nos. SAT-LOA-20051221-00267, SAT-AMD-20060120-00007, SAT-MOD-20060329-00031 (granted by grant stamp on May 11, 2006).
3. Nothing in this authorization shall extend the license term of the EchoStar 10 space station, which will expire on April 10, 2016.
4. DISH is afforded 30 days from the date of release of this grant and authorization to decline this authorization as conditioned. Failure to respond within this period will constitute formal acceptance of the authorization as conditioned.
5. This action is issued pursuant to Section 0.261 of the Commission's rules on delegated authority, 47 C.F.R. § 0.261, and is effective upon immediately. Petitions for reconsideration under Section 1.106 or applications for review under Section 1.115 of the Commission's rules, 47 C.F.R. §§ 1.106, 1.115, may be filed within 30 days of the date of the public notice indicating that this action was taken.
