The application of Iridium Constellation LLC (Iridium), IBFS File No. SAT-MOD-20101001-00207, to extend the license term for its "Big LEO" non-geostationary orbit Mobile-Satellite Service constellation IS GRANTED in part and DEFERRED in part. Specifically, Iridium is authorized to continue the operations of its current constellation in the 1617.775-1626.5 MHz (service link), 19.4-19.6 GHz (feeder downlink and TT&C), 29.1-29.3 GHz (feeder uplink and TT&C), and 23.18-23.38 GHz (inter-satellite link) frequency bands for a term ending January 31, 2018. We defer action on Iridium's request to extend its operating authority for the current satellites beyond January 31, 2018. The remaining portion of Iridium's application will be resolved based on information developed in IBFS File Nos. SAT-MOD-20131227-00148 and SAT-MOD-20080701-00140 concerning future service requirements and end-of-life maneuver capabilities.
