LightSquared Subsidiary LLC (“LightSquared Sub”), formerly SkyTerra Subsidiary LLC, is a U.S. limited liability company.¹ The Commission recently reviewed and approved the ownership and foreign ownership levels of LightSquared Sub, and detailed ownership information is provided in that proceeding and is hereby incorporated by reference.²
