The application of DISH Operating L.L.C. (DISH), IBFS File No. SAT-MOD-20120124-00011, to modify the authorization for its Direct Broadcast Satellite (DBS) service space station, EchoStar 7 (Call Sign S2740), is GRANTED. Accordingly, the license term for the EchoStar 7 space station is extended from April 22, 2012, until April 22, 2022. During this period, DISH is authorized to operate EchoStar 7 using DBS channels 1-21 in the 12.2-12.7 GHz (space-to-Earth) and 17.3-17.8 GHz (Earth-to-space) frequency bands at the 118.8° W.L. orbital location. Operations under this authorization must be in accordance with the terms, conditions, and technical specifications set forth in DISH's application and the Federal Communications Commission's rules, and are subject to the following conditions:

1. DISH must operate EchoStar 7 in accordance with the terms of its current authorization, IBFS File Nos. SAT-MOD-20100329-00058 and SAT-AMD-20100610-00127.
2. DISH is afforded 30 days from the release of this grant and authorization to decline this authorization as conditioned. Failure to respond within this period will constitute acceptance of this authorization as conditioned.
3. This authorization is granted pursuant to Section 0.261 of the Commission's rules on delegated authority, 47 C.F.R. § 0.261, and is effective immediately. Petitions for reconsideration under Section § 1.106 or applications for review under Section 1.115 of the Commission's rules, 47 C.F.R. §§ 1.106, 1.115, may be filed within 30 days of the date of the public notice indicating this action was taken.
