RESPONSE TO QUESTION 40: OWNERSHIP AND CONTROL OF GEOEYE

The Applicant, GeoEye License Corp. (“GeoEye”), is a Delaware corporation. GeoEye is a wholly owned subsidiary of GeoEye Imagery Collection Systems Inc. (“GeoEye Imagery”), which, in turn, is a wholly owned subsidiary of GeoEye, Inc. The address for each of the GeoEye entities named above is: Dulles Corner Office Center, 2325 Dulles Corner Boulevard, Herndon, Virginia 20171. Prior to January 2010, when GeoEye, Inc. changed the name of its subsidiaries, GeoEye Imagery was known as ORBIMAGE Inc., and GeoEye was known as ORBIMAGE License Corp.
