The application of SES Americom, Inc. (SES Americom), IBFS File No. SAT-MOD-20120629-00109, to modify the authorization for its geostationary-satellite orbit space AMC-3 (Call Sign S2162) is GRANTED.¹ Accordingly, the license term for the AMC-3 space station is extended from September 30, 2012, until September 30, 2017. During this period, SES Americom is authorized to continue to provide Fixed-Satellite Service via AMC-3 at the 67° W.L. orbital location in the 3700-4200 MHz (Earth-to-space), 5925-6425 MHz (space-to-Earth), 11.7-12.2 GHz (space-to-Earth) and 14.0-14.5 GHz (Earth-to-space) frequency bands. SES Americom is also authorized to continue to conduct telemetry, tracking, and command operations necessary to maintain AMC-3 at 67° W.L. using center frequencies located at 3700.5 MHz (space-to-Earth), 4199.5 MHz (space-to-Earth), 12.198 GHz (space-to-Earth), and 6423.5 MHz (Earth-to-space). Operations under this authorization must be in accordance with the terms, conditions, and technical specifications set forth in SES Americom's application and the Federal Communications Commission's rules, and are subject to the following conditions:

1. SES Americom must comply with all terms and conditions of the authorization for the AMC-3 space station adopted in IBFS File No. SAT-MOD-20111220-00243 (granted June 28, 2012).
2. SES Americom is afforded thirty days from the date of release of this grant and authorization to decline the authorization as conditioned. Failure to respond within this period will constitute formal acceptance of the authorization as conditioned.
3. This action is taken pursuant to the Commission's rules on delegated authority, 47 C.F.R. § 0.261, and is effective immediately. Petitions for reconsideration under Section 1.106, or applications for review under Section 1.115 of the Commission's rules, 47 C.F.R. §§ 1.106, 1.115, may be filed within 30 days of the date of the public notice indicating that this action was taken.
