Liberty Media Corporation, a Delaware corporation, has filed an Amendment to its Schedule 13D (the "Schedule 13D Amendment") disclosing that it beneficially owns 3,203,666,978 shares of Sirius XM common stock as of September 17, 2012. This amount includes (i) 1,293,509,076 shares of common stock issuable upon the conversion of all of the outstanding shares of Sirius XM's B-1 Preferred Stock, (ii) 5,866,666 shares of Common Stock issuable upon the exchange of \$11 million aggregate principal amount of Sirius XM's 7% Exchangeable Senior Subordinated Notes due 2014 (the "Exchange Notes") beneficially owned by Liberty Media and (iii) the 41,087,753 shares that may be purchased upon physical settlement under a forward contract. This amount represents approximately 49.5% of the outstanding shares of Sirius XM's common stock (as calculated pursuant to Rule 13d-3 of the Securities Exchange Act of 1934, as amended). Malone, a U.S. citizen, owns shares of Liberty Media Corporation representing approximately 40.7% of the aggregate voting power of the company as of May 31, 2012. No other entities or individuals hold a 10% or greater direct or indirect ownership or voting interest in Sirius XM.
