The application of Intelsat License LLC (Intelsat), IBFS File No. SAT-MOD-20130830-00110, for a modification of the authorization for the Intelsat 8 space station (Call Sign S2460), is GRANTED.<sup>1</sup> Accordingly, the license term for the Intelsat 8 space station is extended from December 4, 2013, through June 30, 2016. During this period, Intelsat is authorized to continue to operate Intelsat 8 at the 169.0° E.L. orbital location to provide Fixed-Satellite Services in the in the 3700-4200 MHz (space-to-Earth), 5925-6425 MHz (Earth-to-space), 12.25-12.75 GHz (space-to-Earth), and 14.0-14.5 GHz (space-to-Earth) frequency bands. Operations under this authorization must be in accordance with the terms, conditions, and technical specifications set forth in Intelsat's application and the rules of the Federal Communications Commission, and are subject to the following conditions:

1. Intelsat must continue to operate the Intelsat 8 space station at the 169.0° E.L. orbital location subject to the conditions placed on the authorization granted on August 9, 2013.<sup>2</sup>
2. End-of-life maneuvers for the Intelsat 8 space station must be conducted pursuant to the post-mission disposal plan previously approved in IBFS File No. SAT-MOD-20120619-00100.
3. Within 30 days of completion of the end-of-life maneuvers, Intelsat must send a letter to the Chief, Satellite Division, International Bureau, indicating the apogee and perigee of the Intelsat 8 disposal orbit.
4. Intelsat is afforded 30 days from the date of release of this grant and authorization to decline this authorization as conditioned. Failure to respond within this period will constitute formal acceptance of the authorization as conditioned.
5. This action is issued pursuant to Section 0.261 of the Commission's rules on delegated authority, 47 C.F.R. § 0.261, and is effective immediately. Petitions for reconsideration under Section 1.106 of the Commission's rules or applications for reconsideration under Section 1.115 of the Commission's rules, 47 C.F.R. §§ 1.106, 1.115, may be filed within 30 days of the public notice indicating that this action was taken.
