The application of DIRECTV Enterprises, LLC (DIRECTV), IBFS File No. SAT-MOD-20140127-00010, for a modification of the authorization for the DIRECTV 7S direct broadcast satellite service (DBS) space station (Call Sign S2455) IS GRANTED.¹ Accordingly, the license term for the DIRECTV 7S space station, operating at the 119.05° W.L. orbital location in the 12.2-12.7 GHz (space-to-Earth) and 17.3-17.8 GHz (Earth-to-space) frequency bands, is extended from June 4, 2014, until April 4, 2021. DIRECTV operations under this authorization must be in accordance with the terms, conditions, and technical specifications set forth in DIRECTV's application and the rules of the Federal Communications Commission, and are subject to the following conditions:

1. DIRECTV must continue to operate the DIRECTV 7S space station at the 119.05° W.L. orbital location subject to the conditions in prior authorizations.²
2. Within 30 days of completion of the end-of-life maneuvers, DIRECTV must send a letter to the Chief, Satellite Division, International Bureau, indicating the apogee and perigee of the DIRECTV 7S disposal orbit.
3. DIRECTV is afforded 30 days from the date of release of this grant and authorization to decline this authorization as conditioned. Failure to respond within this period will constitute formal acceptance of the authorization as conditioned.
4. This action is issued pursuant to Section 0.261 of the Commission's rules on delegated authority, 47 C.F.R. § 0.261, and is effective immediately. Petitions for reconsideration under Section 1.106 of the Commission's rules or applications for reconsideration under Section 1.115 of the Commission's rules, 47 C.F.R. §§ 1.106, 1.115, may be filed within 30 days of the public notice indicating that this action was taken.
