The application of XM Radio Inc. (XM Radio), IBFS File No. SAT-MOD-20140515-00052, to modify its authorization for the XM-4 space station (Call Sign S2616) by extending the license term through December 15, 2022, is GRANTED. XM-4 is authorized to continue to provide Satellite Digital Audio Radio Service (SDARS) at the 115.25° W.L. orbital location using the 2332.5-2345 MHz frequency band and to receive feeder links in the 7025-7075 MHz frequency bands. XM Radio is also authorized to continue to conduct Telemetry, Tracking, and Command (TT&C) operations in the 2332.5-2345 MHz and 7025-7075 MHz frequency bands necessary to maintain the XM-4 space station at the 115.25° W.L. orbital location. All operations of under this authorization must be in accordance with the technical specifications set forth in XM Radio's application and the Commission's rules not waived herein, and are subject the conditions set forth below.


1. XM Radio is authorized to operate XM-4 at the 115.25° W.L. orbital location with an East-West station-keeping tolerance of +/-0.1 degrees, pursuant to the waiver of Section 25.210(j), 47 C.F.R. § 25.210(j), of the Commission's rules granted in IBFS File No. SAT-MOD-20100722-00165, as conditioned in that authorization.

2. XM Radio Inc. is authorized to operate XM-4 at the 115.25° W.L. orbital location with the capability of operating in the 7025-7075 MHz frequency band (Earth-to-space) designated for SDARS feeder-link use, in accordance with the technical specifications set forth in IBFS File No. SAT-RPL-20040212-00018 and consistent with the Commission's rules. Operations of XM-4 in the 7025-7075 MHz band at 115.25° W.L. is contingent on successful coordination of these operations with Fixed and Mobile service stations that are lawfully operating in this band.

3. XM Radio must operate the XM-4 space station in compliance with international coordination agreements with Canada and Mexico that limit the power flux density level from U.S .-licensed SDARS space stations into Canada and Mexico.

4. XM Radio has 30 days from the date of this grant to decline this authorization as conditioned. Failure to respond within that period will constitute formal acceptance of the authorization as conditioned.

5. This action is taken on delegated authority pursuant to 47 C.F.R. § 0.261 and is effective upon release. Petitions for reconsideration under 47 C.F.R. § 1.106 or applications for review under 47 C.F.R. § 1.115 may be filed within 30 days of the date of the Public Notice announcing this action.
