The application of Skynet Satellite Corporation (Skynet), IBFS File No. SAT-MOD-20141204-00125, to modify the authorization for the Telstar 12 space station (Call Sign S2462), is GRANTED.¹ Accordingly, the license term for the Telstar 12 space station is extended from December 10, 2014, until November 30, 2017. During this period, Skynet is authorized to continue to operate Telstar 12 in the 10.95-11.20 GHz (space-to-Earth), 11.45-11.7 GHz (space-to-Earth), 12.5-12.75 GHz (space-to-Earth), and the 13.75-14.0 GHz (Earth-to-space) frequency bands to provide fixed-satellite service from the 15° W.L. orbital location. Operations under this authorization must be in accordance with the terms, conditions, and technical specifications set forth in Skynet's application and the rules of the Federal Communications Commission, and are subject to the following conditions:

1. Skynet must comply with terms and conditions of the authorization for the Telstar 12 space station adopted in *Loral Orion Services, Inc. Application for Modification of Space Station Authority*, Order and Authorization, 15 FCC Red 12419 (Int'l Bur. 2000).²
2. Skynet is afforded 30 days from the date of release of this grant and authorization to decline this authorization as conditioned. Failure to respond within this period will constitute formal acceptance of the authorization as conditioned.
3. This action is issued pursuant to Section 0.261 of the Commission's rules on delegated authority, 47 C.F.R. § 0.261, and is effective immediately. Petitions for reconsideration under Section 1.106 of the Commission's rules or applications for reconsideration under Section 1.115 of the Commission's rules, 47 C.F.R. §§ 1.106, 1.115, may be filed within 30 days of the public notice indicating that this action was taken.
