The application of Intelsat License LLC (Intelsat), IBFS File No. SAT-MOD-20150430-00032, for a modification of the authorization for the Intelsat 9 space station (Call Sign S2380), is GRANTED.¹ Accordingly, the license term for the Intelsat 9 space station is extended from September 6, 2015, until July 31, 2017. During this period, Intelsat is authorized to continue to operate Intelsat 9, in inclined orbit,² at the 43.1° W.L. orbital location, to provide Fixed-Satellite Service (FSS) in the 3700-4200 MHz (space-to-Earth), 5925-6425 MHz (Earth-to-space), 11.45-11.7 GHz (space-to-Earth), 11.7-12.2 GHz (space-to-Earth), and 14.0-14.5 GHz (Earth-to-space) frequency bands. Intelsat is also authorized to continue to conduct telemetry, tracking, and command functions necessary to maintain the Intelsat 9 space station at the 43.1° W.L. orbital location using the following center frequencies: 11.7005 GHz (space-to-Earth), 11.7025 GHz (space-to-Earth), 14.4945 GHz (Earth-to-space), and 14.0005 GHz (Earth-to-space). Operations under this authorization must be in accordance with the terms and conditions contained in Intelsat's application and the Federal Communications Commission's rules not waived herein, and are subject to the following conditions:

1. Intelsat must continue to operate the Intelsat 9 space station at the 43.1° W.L. location subject to the conditions in the prior modification granted on May 21, 2014.³
2. Intelsat must maintain its space station within an east-west longitudinal station-keeping tolerance of $\pm .05^\circ$ of the 43.1° W.L. orbital location.
3. Intelsat must operate Intelsat 9 at the 43.1° W.L. orbital location in accordance with any existing or future coordination agreements for this location.
4. In connection with the provisions of service in any particular country, Intelsat is obliged to comply with the applicable laws, regulations, rules, and licensing procedures of that country.
5. Upon expiration of the license term, Intelsat is responsible for the proper disposal of Intelsat 9 by moving it to a minimum altitude of 150 kilometers above the geostationary arc.
6. Within 30 days of completion of the end-of-life maneuvers, Intelsat shall send a letter to the Chief, Satellite Division, International Bureau, indicating the apogee and perigee of the Intelsat 9 disposal orbit.
