The application of SES Americom, Inc. (SES Americom), IBFS File No. SAT-MOD-20151222-00086, for a modification of the authorization for the AMC-8 space station (Call Sign S2379), is GRANTED. Accordingly, the license term for the AMC-8 space station is extended from March 1, 2016, until June 30, 2020. During this period, SES is authorized to continue to operate AMC-8 at the 139° E.L. orbital location, to provide Fixed-Satellite Service in the 5.925-6.425 GHz (Earth-to-space) and 3.700-4.200 GHz (space-to-Earth) frequency bands. Operations under this authorization must be in accordance with the terms and conditions contained in SES Americom's application and the Federal Communications Commission's rules not waived herein, and are subject to the following conditions:

1. SES Americom must continue to operate the AMC-8 space station at the 139° E.L. location subject to the conditions in the most recent modification and original grant.
2. SES Americom must maintain its space station within an east-west longitudinal station-keeping tolerance of  $\pm .05^\circ$  of the 139° E.L. orbital location.
3. SES Americom must operate AMC-8 at the 139° E.L. orbital location in accordance with any existing or future coordination agreements for this location.
4. In connection with the provisions of service in any particular country, SES Americom is obliged to comply with the applicable laws, regulations, rules, and licensing procedures of that country.
5. SES Americom's request for a waiver of Sections 25.114(d)(14) and 25.283(c), 47 C.F.R. §§ 25.114(d)(14) and 25.283(c) is granted. Section 25.283(c) specifies that space stations must discharge all stored energy sources at end-of-life of the space station. SES Americom indicates that AMC-8 is a Lockheed Martin A2100 spacecraft and was launched on March 1, 2001. SES Americom states that due to its design, AMC-8's two oxidizer tanks were sealed by firing pyrotechnical valves shortly after launch and will not be vented to depletion at the spacecraft's end of life. SES Americom states that the total mass of remaining oxidizer in each of the two tanks will be approximately 6.92 kilograms at end of life, with each tank volume being approximately 229.9 liters. We grant the requested waivers because AMC-8 was launched before Section 25.283(c) was adopted and compliance would require direct retrieval of the satellite, which is not currently possible. In making this determination, however, we note that the information SES submitted for its waiver is not sufficient to support a finding that the intent of the rule would be satisfied by the described procedure for sealing the oxidizer tanks.
6. Within 30 days of completion of the end-of-life maneuvers, SES Americom must send a letter to the Chief, Satellite Division, International Bureau, indicating the apogee and perigee of the AMC-8 disposal orbit.
7. SES Americom is afforded 30 days from the date of release of this grant and authorization to decline this authorization as conditioned. Failure to respond within this period will constitute formal acceptance of the authorization as conditioned.
8. This action is issued pursuant to Section 0.261 of the Commission's rules on delegated authority, 47 C.F.R. § 0.261, and is effective immediately. Petitions for reconsideration under Section 1.106 of the Commission's rules or applications for
