Intelsat must operate Intelsat 701 at the 29.5° W.L. orbital location in accordance with any existing or future coordination agreements for this location. 4. In connection with the provisions of service in any particular country, Intelsat is obliged to comply with the applicable laws, regulations, rules, and licensing procedures of that country. 5. Upon expiration of the license term, Intelsat is responsible for the proper disposal of Intelsat 701 by moving it to a minimum altitude of 150 kilometers above the geostationary arc.
