SES must maintain the AMC-1 space station at the 129.15° W.L. orbital location with an east/west longitudinal station-keeping tolerance of ± 0.05 degrees. 3. Within 30 days of completion of the end-of-life maneuvers, SES must send a letter to the Chief, Satellite Division, International Bureau, indicating the apogee and perigee of the AMC-1 disposal orbit. 		

¹ While the AMC-1 space station is capable of operating in both the C- and Ku-band, SES does not proposed to operate the AMC-1 C-band communications payload frequencies while the spacecraft is located at 129.15° W.L., but does propose to use limited C-band frequencies for TT&C. See IBFS File No. SAT-AMD-20150219-00006, Technical Appendix at 2-4.


