Intelsat must maintain its space station within an east-west longitudinal station-keeping tolerance of +/- .05° of the 93.10° W.L. orbital location. 3. Intelsat must operate Galaxy 25 at the 93.10° W.L. orbital location in accordance with any existing or future coordination agreements for this location. 4. Within 30 days of the last north-south station-keeping maneuver and the commencement of inclined orbit operations of Galaxy 25, Intelsat shall send a letter to the Chief, Satellite Division, International Bureau, including the date inclined orbit operations commenced, the initial inclination, the rate of change in inclination per year, and the expected end-of-life of Galaxy 25 accounting for inclined orbit operations.² 5. Upon expiration of the license term, Intelsat is responsible for the proper disposal of Galaxy 25 by moving it to a minimum altitude of 300 kilometers above the geostationary arc.³ 6. Within 30 days of completion of the end-of-life maneuvers, Intelsat shall send a letter to the Chief, Satellite Division, International Bureau, indicating the apogee and perigee of the Galaxy 25 disposal orbit.
