administrations, coordination agreements are successfully completed. Any radio station authorization for which coordination has not been completed may be subject to additional terms and conditions as required to effect coordination of the frequency assignments of other administrations. *See* 47 CFR § 25.111.

2. All operations during the drift of Intelsat 9 to the 50.0° W.L. orbital location must be on an unprotected and non-harmful interference basis, *i.e.*, Intelsat must not cause harmful interference to, and must not claim protection from interference caused to it by, any other lawfully operating stations. In the event of any harmful interference, Intelsat shall cease operations immediately upon notification of such interference, and shall inform the Commission, in writing, immediately of such an event.
3. Intelsat must coordinate the operations of Intelsat 9 with existing geostationary space stations to ensure that no unacceptable interference results from its operations during drift to the 50.0° W.L. orbital location.
4. Intelsat must operate only the TT&C frequencies on Intelsat 9 during the space station's drift from 66.15° E.L. to 50.0° W.L.
5. Intelsat must operate Intelsat 9 at the 50.0° W.L. orbital location in accordance with any existing or future coordination agreements for this location. In the absence of a coordination agreement, such operations must comply with applicable provisions of the ITU Radio Regulations as the Commission cannot guarantee the success of the required coordination.
6. In connection with the provisions of service in any particular country, Intelsat is obliged to comply with the applicable laws, regulations, rules, and licensing procedures of that country.
7. While at the 50.0° W.L. orbital location, Intelsat must maintain the Intelsat 9 spacecraft with an east/west longitudinal station-keeping tolerance of +/- 0.05 degrees.
8. The operations of Intelsat 9 in the 3700-4200 MHz band, within the contiguous United States, are subject to the terms of *3.7-4.2 GHz Report and Order* (FCC 20-22), including Section 2.106, footnote NG182 and footnote NG457A, once in effect. In the interim, Intelsat 9's operations are subject to the terms of the *3.7-4.2 GHz Space Station Freeze Order*, GN Docket No. 17-183, Public Notice, 33 FCC Rcd 6119 (IB 2018).
9. Intelsat's operations of Intelsat 9 at the 50.0° W.L. orbital location in the 3700-4200 MHz (space-to-Earth), 5925-6425 MHz (Earth-to-space), 10.95-11.2 GHz (space-to-Earth), 11.45-11.7 GHz (space-to-Earth), 11.7-12.2 GHz (space-to-Earth), and 14.0-14.5 GHz (Earth-to-space) frequency bands are subject to the following additional conditions:
  - a. Intelsat shall remain a signatory to the Public Services Agreement between Intelsat and the International Telecommunications Satellite Organization (ITSO) that was approved by the ITSO Twenty-fifth Assembly of Parties, as amended.
  - b. No entity shall be considered a successor-in-interest to Intelsat under the ITSO Agreement for licensing purposes unless it has undertaken to perform the obligations of the Public Services Agreement approved by the Twenty-fifth Assembly of Parties, as amended.
10. The U.S. Administration will not object to the use of the Intelsat 9 satellite by the Papua New Guinea Administration for claiming bringing into use or continuing the use of the NEW DAWN 35 ITU filing at 50.0° W.L. in the 11.95-12.2 GHz frequency band.
11. The operations of Intelsat 9 and associated earth stations must comport with the applicable uplink and downlink limits in 47 CFR § 25.140(a)(3) of the Commission's rules, unless Intelsat coordinates any non-conforming operations with the operations of U.S.-licensed geostationary orbit space stations within 6 degrees of the 50.0° W.L. orbital location. Intelsat must also comport with the maximum power limits indicated in existing or future coordination agreements at 50.0° W.L. Non-conforming operation must also be coordinated with respect to those operations of non-U.S.-licensed space stations within 6 degrees

of 50.0° W.L. involving approved communications with U.S.-licensed earth stations.

12. The power flux-density (PFD) at the Earth's surface produced by the emissions from the Intelsat 9 space station, in the 3700-4200 MHz and 11.45-11.7 GHz frequency bands (space-to-Earth), must not exceed the applicable power flux-density limits contained in No.21.16 in Article 21 of the ITU Radio Regulations.
13. Intelsat 9's operations in the 5925-6425 MHz and 14-14.5 GHz (Earth-to-space) bands are subject to No. 5.457A of the ITU Radio Regulations; which states that earth stations located on board vessels may communicate with space stations of the fixed-satellite service. Such use shall be in accordance with Resolution 902 (WRC-03).
14. Intelsat's request for waiver of footnote NG52 of the U.S. Table of Frequency Allocations, 47 CFR § 2.106, NG52,<sup>3</sup> to use the 11.45-11.7 GHz band to offer domestic services on an unprotected, non-harmful interference basis in the United States IS GRANTED, as conditioned. We find that waiver does not undermine the purpose of the rule because the waiver involves only earth stations that are receive-only in the 11.45-11.7 GHz frequency band and thus are not capable of causing interference into fixed stations operating in this band. Furthermore, because Intelsat has agreed to accept any level of interference from fixed stations into receive earth stations in this band, fixed station operators will not be required to coordinate their station operations with Intelsat's earth stations' operations.<sup>4</sup> Under these circumstances, we determine that an additional coordination burden is not placed upon fixed station operators and their ability to expand service in the future would not be restricted in any manner.<sup>5</sup>
  - a. Intelsat's space-to-Earth transmissions in the 11.45-11.7 GHz band are to be conducted without interference protection from fixed stations to earth stations receiving these transmissions. This applies to fixed stations to which frequencies in the 11.45-11.7 GHz band have either been already assigned, or to which frequencies in the 11.45-11.7 GHz band may be assigned at a later date.
  - b. Intelsat must inform its customers, in writing, including end-users receiving service from resellers accessing capacity on the Intelsat 9 space station, that domestic service in the 11.45-11.7 GHz band is being provided on an unprotected basis, and that the potential exists that future licensed fixed stations may cause harmful interference to unprotected receive earth stations in the 11.45-11.7 GHz band.
15. Intelsat's use of the 11.45-11.7 GHz frequency band is subject to footnote US211 to the United States Table of Frequency Allocations, 47 CFR § 2.106, US211, which urges applicants for airborne or space station assignments to take all practicable steps to protect radio astronomy observations in the adjacent bands from harmful interference, consistent with footnote US74.
16. Operations of Intelsat 9 in the 14.47-14.5 GHz (Earth-to-space) frequency band is subject to the terms of footnotes 5.149 and US342 to the United States Table of Frequency Allocations, 47 CFR §2.106, 5.149, US342, which urge applicants to take all practicable steps to protect the radio astronomy service from harmful interference.
17. Prior to commencing operations with the Intelsat 9 space station, Intelsat must file with the Commission the information required by section 25.172 of the Commission's rules, 47 CFR § 25.172.

18. The license term for the Intelsat 9 space station is extended from July 31, 2021, through October 31, 2022.
19. Upon expiration of the license term, Intelsat is responsible for the proper disposal of Intelsat 9 by moving it to a minimum altitude of 150 kilometers above the geostationary arc.
20. Within 30 days of completion of the end-of-life maneuvers, Intelsat shall send a letter to the Chief, Satellite Division, International Bureau, indicating the apogee and perigee of the Intelsat 9 disposal orbit.

Licensee/grantee is afforded thirty (30) days from the date of release of this action to decline the grant as conditioned. Failure to respond within this period will constitute formal acceptance of the grant as conditioned.


