

DISH must also continue to comply with the conditions set forth in file nos. SAT-LOA-20090518-00053, SAT-AMD-20090604-00064, and SAT-MOD-20100212-00027.
2. In connection with the provision of service in any particular country, DISH is obliged to comply with the applicable laws, regulations, rules, and licensing procedures of that country.
3. While at the 118.9° W.L. orbital location, DISH must maintain the EchoStar 14 spacecraft with an east/west longitudinal station-keeping tolerance of +/- 0.05 degrees.
4. The license term for Call Sign S2790 is extended from May 27, 2020, through May 27, 2027.

Licensee/grantee is afforded thirty (30) days from the date of release of this action to decline the grant as conditioned. Failure to respond within this period will constitute formal acceptance of the grant as conditioned.

This action is taken pursuant to Section 0.261 of the Commission's rules on delegated authority, 47 C.F.R. § 0.261, and is effective upon release.
