Unless otherwise specified herein, operations under this grant must comport with the legal and technical specifications set forth by the applicant or petitioner and with the Federal Communications Commission's rules not waived herein. This grant is also subject to the following conditions:

1. Ligado must continue to comply with all terms and conditions applied to the operation of the MSAT-2 space station under call sign AMSC-1 throughout the extended license term.³
2. Upon receipt of a conjunction warning from the JSpOC or other source, Ligado must review the warning and take all possible steps to assess and, if necessary, to mitigate collision risk, including, but not limited to: contacting the operator of any active spacecraft involved in such warning; sharing ephemeris data and other appropriate operational information with any such operator; modifying spacecraft attitude and/or operations.
3. The operations of MSAT-2 at the 107.5° W.L. orbital location must otherwise comply with the conditions imposed in its prior authorizations. IBFS File No. SAT-MOD-20180912-00070 (granted Nov. 25, 2018), and SAT-MOD-20201201-00138 (granted Feb. 17, 2021).
4. Ligado is authorized to operate the MSAT-2 space station with an East-West station-keeping tolerance of +/- 0.1 degrees. Section 25.210(j) of the Commission's rules, 47 CFR § 25.210(j), states that space stations "must be maintained within 0.05 degrees of their assigned orbital longitude in the east/west direction, unless specifically authorized by the Commission to operate with a different longitudinal tolerance. Ligado states that there will be no overlap with any existing or planned neighboring space stations at the 106.5° W.L. orbital location. MSAT-2's east-west +/- 0.1 degree station-keeping operations shall terminate in the event that a satellite is launched into a location such that its station-keeping volume would overlap MSAT-2's +/-0.1 degree station-keeping volume, but would not overlap MSAT-2's +/- 0.05 degree station-keeping volume, unless Ligado has successfully coordinated MSAT-2's physical operations with those of the other spacecraft. This authorization is limited to this spacecraft, does not extend any other spacecraft, and it is limited to operations at the 107.5° W.L. orbital location.⁴

Licensee/grantee is afforded thirty (30) days from the date of release of this action to decline the grant as conditioned. Failure to respond within this period will constitute formal acceptance of the grant as conditioned.

This action is taken pursuant to Section 0.261 of the Commission's rules on delegated authority, 47 CFR § 0.261, and is effective upon release.

Station licenses are subject to the conditions specified in Section 309(h) of the Communications Act of 1934, as amended, 47 U.S.C. § 309(h).
