SpaceLink Corporation (SpaceLink) petitions the FCC to modify NGSO Call Sign S2982 to (1) include operations in the 25.25-27.50 GHz, (2) add a fourth satellite, (3) permit the operation of all satellites from an equatorial orbit at the already authorized altitude, and (4) increase EIRP density with respect to certain inter-satellite frequencies.
