WorldVu Satellites Limited (“OneWeb”), by its undersigned counsel, hereby submits a copy of a rider to the performance bond currently on file with the Commission for the OneWeb Market Access Grant.¹ The attached bond rider supplements OneWeb’s original surety bond filed with the Commission on July 18, 2017 and previous bond riders filed with the Commission on June 12, 2018, June 20, 2019, June 22, 2020, and June 22, 2021.² The attached bond rider increases the maximum penal sum of the original surety bond in compliance with the Commission’s rules and the terms of the OneWeb Market Access Grant.³

BOND RIDER

To be attached to and form a part of Bond No. 0714417 in the amount of Four Million Three Hundred Thirty Thousand and 00/100 Dollars (\$4,330,000.00) issued by International Fidelity Insurance Company, as Surety, on behalf of WorldVu Satellites Limited, as Principal, in favor of the United States Treasury, as Obligee, on June 23, 2017 (the "Bond").

WHEREAS, the above bounden Principal has obtained authorization from the Federal Communications Commission ("FCC") for authority to access the United States market using a Non-geostationary (NGSO) satellite system pursuant to its application, FCC File No. SAT-LOI-20160428-00041; Call Sign S2963 ("Authorization"), in accordance with the terms and conditions set forth in the Conditions for Letter of Intent attached to the FCC's grant of that Authorization on 06/23/2017 as required by the FCC rules then in effect, including the filing of this Bond with the FCC pursuant to the Authorization grant; and

WHEREAS, the Bond provides that the maximum penal sum of the Bond may be increased on an annual basis with the Surety's consent, via a rider to the Bond sent to the FCC and the Obligee. Such riders will increase the maximum penal sum to the required amount in accordance with the following formula, with all sums expressed in U.S. Dollars: $A = \$1,000,000.00 + \$4,000,000.00 * D / 2,192$, where A is the penal sum to be paid and D is the lesser of 2,192 or the number of days that have elapsed from the date of the Authorization grant until the date when the Authorization was surrendered.

It is hereby understood and agreed that the maximum penal sum of the Bond is hereby increased to:

Five Million and 00/100 Dollars (\$5,000,000.00)

as of June 23, 2022.

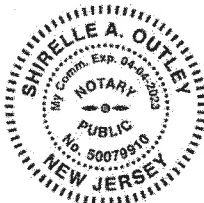

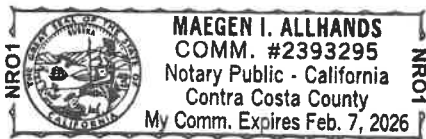
