WorldVu Satellites Limited (“OneWeb”) hereby submits an executed copy of the surety bond rider for the OneWeb non-geostationary, fixed-satellite system granted U.S. market access in the V-band in August 2020.¹ The attached surety bond rider further supplements OneWeb’s original surety bond filed with the Commission on September 24, 2020.² The attached bond rider increases the maximum penal sum of the original surety bond in compliance with the Commission’s rules and the terms of the OneWeb Market Access Grant.³

Power of Attorney

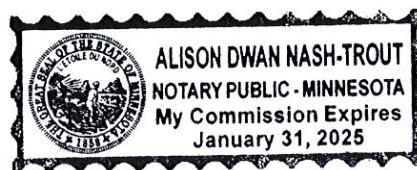
