**REQUEST FOR LEAVE TO FILE CONSOLIDATED RESPONSES**

Intelsat North America LLC ("Intelsat"), by its attorneys, requests leave for interested parties to file on Tuesday, September 30, 2003, consolidated responses to pleadings filed with respect to the above-referenced application.

On September 15, 2003 SES Americom, Inc. ("SES") hand-served the applicants in this proceeding with its pleading. In addition, EchoStar Satellite Corporation ("EchoStar") filed comments on September 15, 2003, but served the applicants by first-class mail.

Pursuant to the Federal Communications Commission's ("Commission's") rules,<sup>1</sup> responses to the SES pleading are due on Thursday, September 25, 2003, while the responses to


