Dear Ms. Dortch:

On July 19, 2021, representatives of Intelsat License LLC, as debtor-in-possession, ("Intelsat"), met via teleconference with Federal Communications Commission International Bureau personnel. The attendees are listed in Attachment A.

During the meeting, Intelsat discussed its November 18, 2020 request (the "ITSO Request") for the Commission to act to obligate Intelsat to continue to provide global connectivity and coverage and non-discriminatory access to the Intelsat system upon termination of the International Telecommunications Satellite Organization agreement ("ITSO Agreement").1

Intelsat explained to the FCC that ITSO planned to convene an Assembly of Parties ("AP") in June 2021 during which the Parties would consider a resolution to terminate the ITSO Agreement.<sup>2</sup> However, Intelsat understands that due to the global COVID-19 pandemic, the June 2021 AP was cancelled and has been rescheduled to occur no later than March 31, 2022.
