**Petition for Declaratory Ruling**

Telesat Canada ("Telesat") respectfully petitions the Federal Communications Commission ("FCC" or "Commission"), pursuant to 47 C.F.R. § 25.137 and the *DISCO II Reconsideration Order*,<sup>1</sup> to include Anik E2R at 111.1° W.L. on the Commission's Permitted Space Station List (the "List"). Telesat currently serves U.S. customers from this orbital location via Anik E2, a satellite included on the List that is nearing the end of its useful life.<sup>2</sup> Grant of this request will permit Telesat to continue serving U.S. customers from 111.1° W.L. pending the launch of Anik F2, a replacement satellite which the Commission placed on the List in December 2002.<sup>3</sup>
