CERTIFICATION OF INTELSAT, LTD.

I, Conny L. Kullman, Chief Executive Officer of Intelsat, Ltd. ("Intelsat"), declare under penalty of perjury as follows:

(i) Upon consummation of Intelsat's transaction with Zeus Holdings Limited (the "Zeus Transaction"), which the Federal Communications Commission ("FCC") approved by Order dated December 22, 2004 (DA 04-4034), Intelsat will achieve substantial dilution of the aggregate amount of former signatory financial interest in Intelsat;


(ii) Upon consummation of the Zeus Transaction, which the FCC approved on December 22, 2004 (DA 04-4034), any signatories or former signatories that retain a financial interest in Intelsat will not possess, together or individually, effective control of Intelsat;

(iii) Upon consummation of the Zeus Transaction, which the FCC approved on December 22, 2004 (DA 04-4034), no intergovernmental organization will have any ownership interest in a successor entity of Intelsat; and

(iv) I have read the foregoing Petition for Declaratory Ruling that Intelsat, Ltd. Complies with Section 621(5)(F) of the ORBIT Act. The representations contained therein are true and correct.
