Dear Ms. Dortch:

Hispamar Satélites, S.A. and Hispasat, S.A (collectively, the “Authorization Holders”), by counsel, notify the Federal Communications Commission (“Commission”) that the transfer of control of the Authorization Holders, which own the permitted list space stations referenced below, to Red Eléctrica Sistemas de Telecomunicaciones, a wholly-owned subsidiary of Red Eléctrica Corporación, S.A., was consummated on October 3, 2019.

The Authorization Holders notified the Commission of the then-proposed transfer of control on March 21, 2019,<sup>1</sup> and the Commission’s Satellite Division determined that the transfer of control does not affect U.S. market access considerations for the Amazonas-2, Amazonas-3, Hispasat 30W-6, or Hispasat 30W-4 satellites.<sup>2</sup>
