## **Ownership of Telesat Canada**

Loral Space & Communications Inc. (Loral), through its wholly-owned subsidiary Loral Holdings Corporation, both U.S. companies, holds 62.64% of the equity of Telesat Canada. Loral through its previously mentioned subsidiary, holds a 32.62% voting interest for all matters.

The Public Sector Pension Investment Board (PSP), through its wholly-owned subsidiary Red Isle Private Investments Inc., a Canadian company, holds 36.75% of the equity of Telesat Canada. PSP is a Canadian Crown corporation established by the Canadian Parliament pursuant to the Public Sector Pension Investment Board Act. PSP holds a 67.38% voting interest for all matters except the election of the board of directors and a 29.36% voting interest for the election of the board of directors.

Certain past and present employees of Telesat Canada hold a combined 0.61% of the equity of Telesat Canada.

John P. Cashman, a citizen of Canada and Ireland, holds a 31.18% voting interest solely for the election of the board of directors of Telesat Canada.

Clare Copeland, who is a Canadian citizen, holds a 6.84% voting interest solely for the election of the board of directors of Telesat Canada.
