

### **RESPONSE TO QUESTIONS 30-33 & 40: Ownership and Officers/Directors**

In response to Questions 30 and 31 of Form 312, Embratel Tvsat Telecomunicações S.A. (“Embratel”) is a corporation organized under the laws of Brazil.

In response to Questions 32, 33, and 40, Embratel is 100% owned and ultimately controlled by América Móvil, S.A.B. de C.V. (“América Móvil”), a corporation organized under the laws of Mexico. Embratel is directly controlled by Claro NXT Telecomunicações S.A. (“Claro NXT”), a corporation organized under the laws of Brazil, which has an ownership share of 68.4% and holds 81.2% of Embratel’s voting shares. The address of Claro NXT Telecomunicações S.A. is Rua Henri Dunant, n° 780, Torre B, andar 3, Santo Amaro, São Paulo/SP, CEP 04709-110. The other 31.6% of Embratel’s ownership shares, and 19.88% of its voting shares, are held by Telmex do Brasil S.A., a corporation organized under the laws of Brazil, which itself is 100% owned and controlled by Claro NXT. The address of Telmex do Brasil S.A. is Rua dos Ingleses, n° 600, 12° andar, São Paulo/SP, CEP 01329-904. Claro NXT is controlled by Claro S.A., a corporation organized under the laws of Brazil, which owns 68.08% of Claro NXT. Claro is directly controlled by Claro Telecom Participações S.A. (“Claro Telecom”), a corporation organized under the laws of Brazil, which holds 83.24% of Claro’s voting shares. The vast majority of Claro’s remaining voting shares—13.71%—are held by Controladora de Servicios de Telecomunicaciones, S.A. de C.V. (“Controladora de Servicios”), a corporation organized under the laws of Mexico. Claro Telecom is owned and controlled by Amov I, S.A. de C.V. (“Amov I”), a corporation organized under the laws of Mexico. Amov I is 100% directly owned and controlled by América Móvil. Controladora de Servicios is also 100% directly owned and controlled by América Móvil.
