

Response to FCC Form 312 Question 40

Satellite CD Radio LLC is a wholly owned subsidiary of Sirius XM Radio Inc., which in turn is a wholly owned subsidiary of Sirius XM Holdings Inc. Sirius XM Holdings Inc. has no operations independent of Sirius XM Radio Inc. As of March 31, 2023, Liberty Media Corporation (“Liberty Media”), a Delaware corporation, beneficially owned approximately 83% of the common stock of Sirius XM Holdings Inc.¹ Dr. John C. Malone, a United States citizen, owned shares of Liberty Media common stock constituting approximately 49% of the aggregate outstanding voting power of the Company, as of January 31, 2023. The address of Liberty Media and Dr. Malone is 12300 Liberty Boulevard, Englewood, CO 80112. No other entities or individuals own a 10% or greater direct or indirect interest in Sirius XM Holdings Inc.
