## Re: SES Americom, Inc. Withdrawal of Pending Request for C-band Authority, File No. SAT-STA-20030402-00061

Dear Ms. Dortch:

SES Americom, Inc. ("SES Americom"), by its attorneys, hereby withdraws, to the extent not already acted upon, its application File No. SAT-STA-20030402-00061 (the "AMC-2 STA").

The AMC-2 STA sought authority to provide C- and Ku-band services from the 105° W.L. orbital location. In an order released July 7, 2003, the Satellite Division acted on the uncontested portions of the AMC-2 STA, granting SES Americom conditional authority for Ku-band operations and C-band TT&C.<sup>1</sup> No action was taken with respect to SES Americom's request for authority to operate the C-band communications payload.

That request is now moot. SES Americom last month submitted a modification application under the Commission's fleet management procedures to relocate AMC-2 from 105° W.L. to 85° W.L.<sup>2</sup> SES Americom recently commenced relocation of AMC-2 pursuant to that authority.
