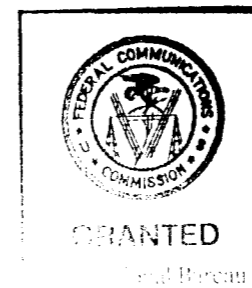

PanAmSat Licensee Corp.'s (PanAmSat) application, IBFS File No. SAT-MOD-20060425-00048 (Call Sign: S2146),<sup>1</sup> to relocate its C-band satellite, GALAXY-9, from 90.9° W.L. orbital location, where it served as an in-orbit spare, to 74.15° W.L. orbital location IS GRANTED. Accordingly, PanAmSat is authorized to operate GALAXY-9 from the 74.15° W.L. orbital location with ±0.05 longitudinal station-keeping, in the 3700 – 4200 MHz (space-to-Earth) and 5925-6425 MHz (Earth-to-space) frequency bands. Other than the change in orbital location, the conditions contained in the prior authorization<sup>2</sup> otherwise remain in effect and the GALAXY-9 satellite will operate in accordance with the terms, conditions, and technical specifications set forth in its application, this Attachment, and the Commission's Rules.

1. PanAmSat shall prepare the necessary information, as may be required, for submission to the ITU to initiate and complete the advance publication, international coordination, due diligence, and notification process of this space station, in accordance with the ITU Radio Regulations. PanAmSat shall be held responsible for all cost recovery fees associated with these ITU filings. We also note that no protection from interference caused by radio stations authorized by other administrations is guaranteed unless coordination and notification procedures are timely completed or, with respect to individual administrations, by successfully completing coordination agreements. Any radio station authorization for which coordination has not been completed may be subject to additional terms and conditions as required to effect coordination of the frequency assignments of other administrations. See 47 C.F.R. § 25.111(b).

The GALAXY-9 satellite must be in operation at the 74.15° W.L. orbital location within 90 days of grant or the authorization shall be null and void by its own terms. See 47 C.F.R. Section 25.161(c).<sup>3</sup>

PanAmSat afforded thirty days from the date of release of this grant and authorization to decline this authorization as conditioned. Failure to respond within this period will constitute formal acceptance of the authorization as conditioned.

This Grant is issued pursuant to Section 0.261 of the Commission's rules on delegated authority, 47 C.F.R. § 0.261, and is effective upon release. Petitions for reconsideration under Section 1.106 or applications for review under Section 1.115 of the Commission's rules, 47 C.F.R. §§ 1.106, 1.115, may be filed within 30 days of the date of the public notice indicating that this action was taken.

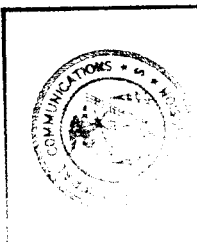
