

The request of DIRECTV Enterprises, LLC ("DIRECTV") for a modification of its authorization, File No. SAT-MOD-20070626-00087, IS GRANTED. Accordingly, DIRECTV IS AUTHORIZED to operate its Fixed-Satellite Service (FSS) Ka-band space station, SPACEWAY 1, at the 102.885° W.L. orbital location in the 18.3–18.8/19.7-20.2 GHz (Downlink) and 28.35-28.60/29.25-30.00 GHz (Uplink) frequency bands. This authorization is granted in accordance with the terms, conditions, and technical specifications set forth in DIRECTV's application, this Attachment, and the Commission's rules:

1. DIRECTV must coordinate all of its Ka-band downlink operations with Federal fixed-satellite systems, both geostationary and non-geostationary, in accordance with footnote US334 to the Table of Frequency Allocations, 47 C.F.R. § 2.106. Absent a coordination agreement pursuant to footnote US334, DIRECTV shall operate its Kaband downlinks on a non-harmful interference basis with regards to Federal systems in the 18.3-18.8 and 19.7-20.2 GHz bands and must terminate its Ka-band downlink operations immediately in the event that such operations cause harmful interference into operating Federal systems. In addition, DIRECTV must accept interference from such systems absent a coordination agreement pursuant to footnote US334.

2.8 DIRECTV must maintain the SPACEWAY 1 satellite at 102.885° W.L. with +/-0.05 degree longitudinal stationkeeping. See 47 C.F.R. § 25.210(i).
