Intelsat New Dawn Company, Ltd. herein requests a grant of Special Temporary Authority for 30 days, from May 28, 2011 through June 26, 2011, to temporarily operate its New Dawn satellite (call sign S2751) at 32.85 E.L. in the bands 3625-4200 MHz (downlink), 5850-6500 MHz (uplink), 10950-11200 MHz and 11450-11700 MHz (downlink), and 14000-14500 MHz (uplink) during traffic transition and subsequently to drift the satellite to its permanent location of 32.8 E.L.
