Operations pursuant to this special temporary authority must be on an unprotected and non-harmful interference basis, i.e., they must not cause harmful interference to, and shall not claim protection from interference caused to it by, any other lawfully operating station. In the event of any harmful interference, Intelsat must cease operations immediately upon notification of such interference, and shall inform the Commission, in writing, immediately of such an event.
2. All other operations of Galaxy 12 at the 129.0° W.L. orbital location must be in accordance with the most recent modification of the authorization for the Galaxy 12 space station, IBFS File No. SAT-MOD-20180215-00017.

Licensee/grantee is afforded thirty (30) days from the date of release of this action to decline the grant as conditioned. Failure to respond within this period will constitute formal acceptance of the grant as conditioned.

This action is taken pursuant to Section 0.261 of the Commission's rules on delegated authority, 47 C.F.R. § 0.261, and is effective upon release.
