Re: Request for Further Extension of Special Temporary Authority to Operate
Intelsat 902 at 50.1° W.L. with New C-band Coverage; Call Sign: S2406

Dear Ms. Dortch:

Intelsat License LLC ("Intelsat") herein requests an additional 30 days of Special Temporary Authority ("STA")¹ previously granted to Intelsat to operate the Intelsat 902 satellite's C-band—telemetry, tracking, and control ("TT&C") and communications frequencies—over new coverage areas in order to satisfy customer service demands.²

Intelsat 902's specific C-band frequencies are:

TT&C

3947.5 MHz, 3948.0 MHz, 3952.0 MHz, and 3952.5 MHz (space-to-Earth); and
6173.7 MHz and 6176.3 MHz (Earth-to-space)

Communications

3625-4200 MHz (space-to-Earth); and
5850-6425 MHz (Earth-to-space)

Intelsat 902 is permanently licensed to operate at 50.1° W.L. with different C-band coverages than requested herein.³ The requested coverage area is being obtained by biasing the satellite platform.⁴ Intelsat's continued operations will conform to all applicable coordination agreements and the Federal Communications Commission's rules governing operations vis-à-vis adjacent locations.

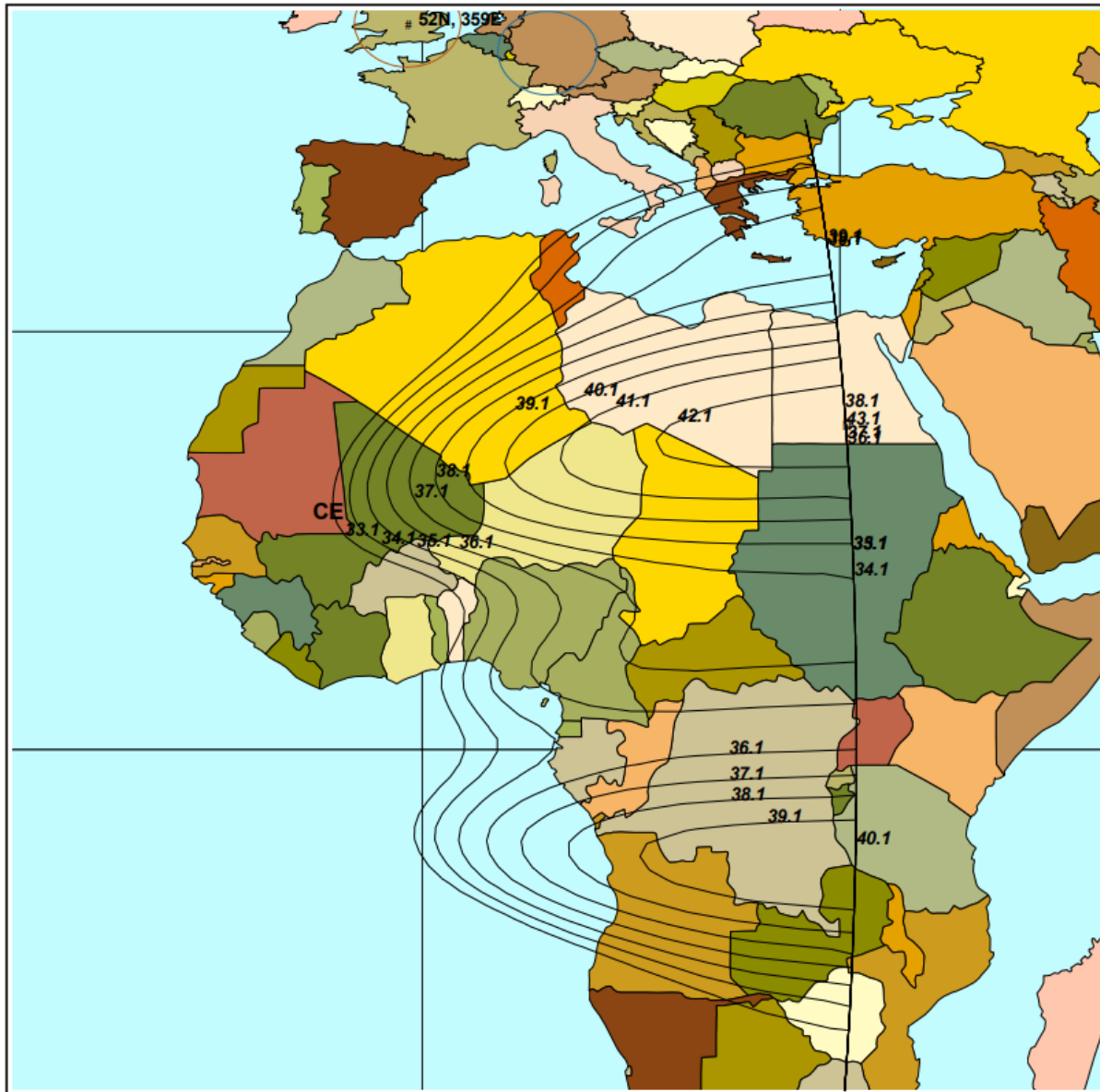

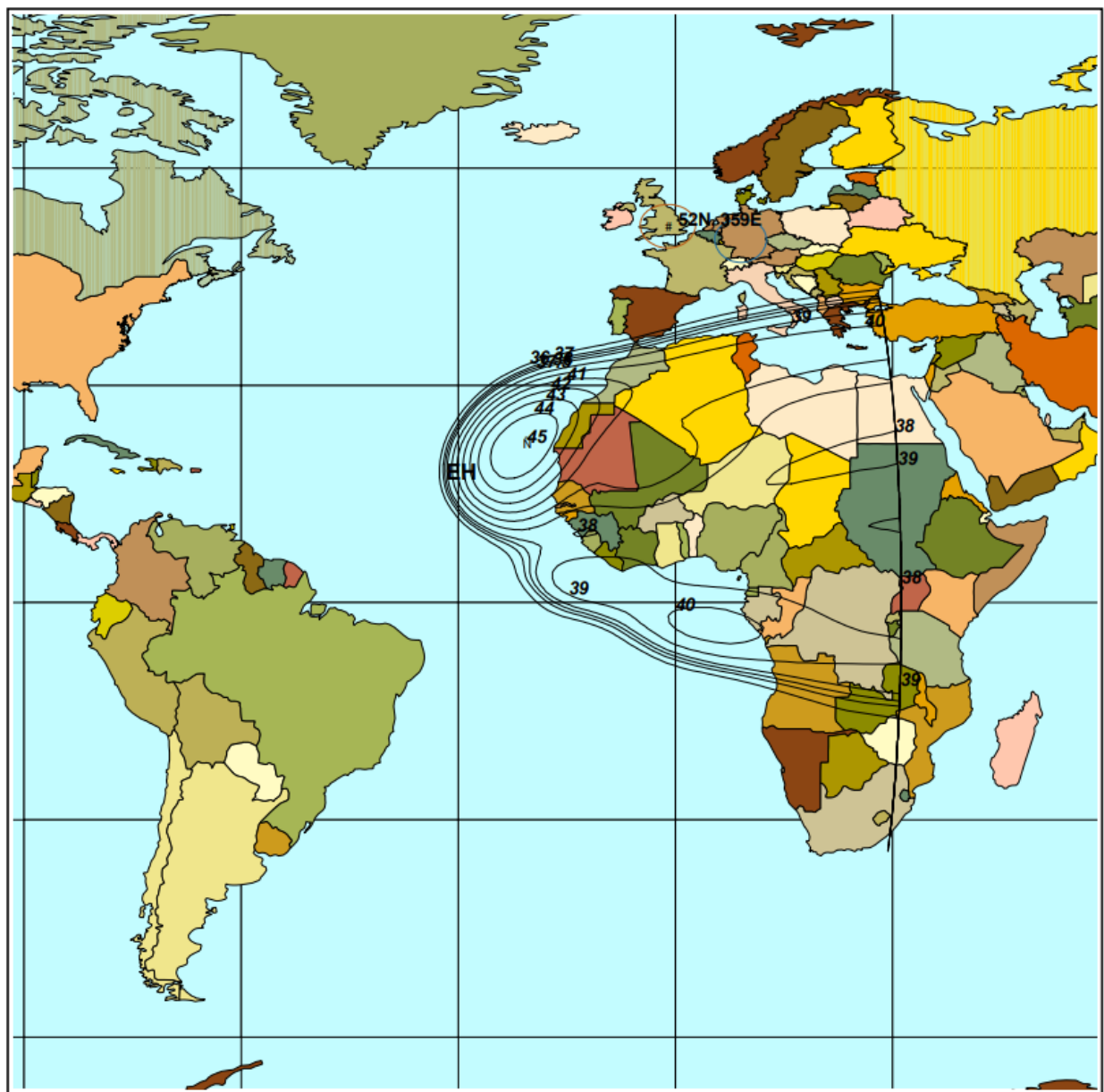

IS-902 at 50.1° W.L./309.9° E.L. Platform Bias New C-band Coverages

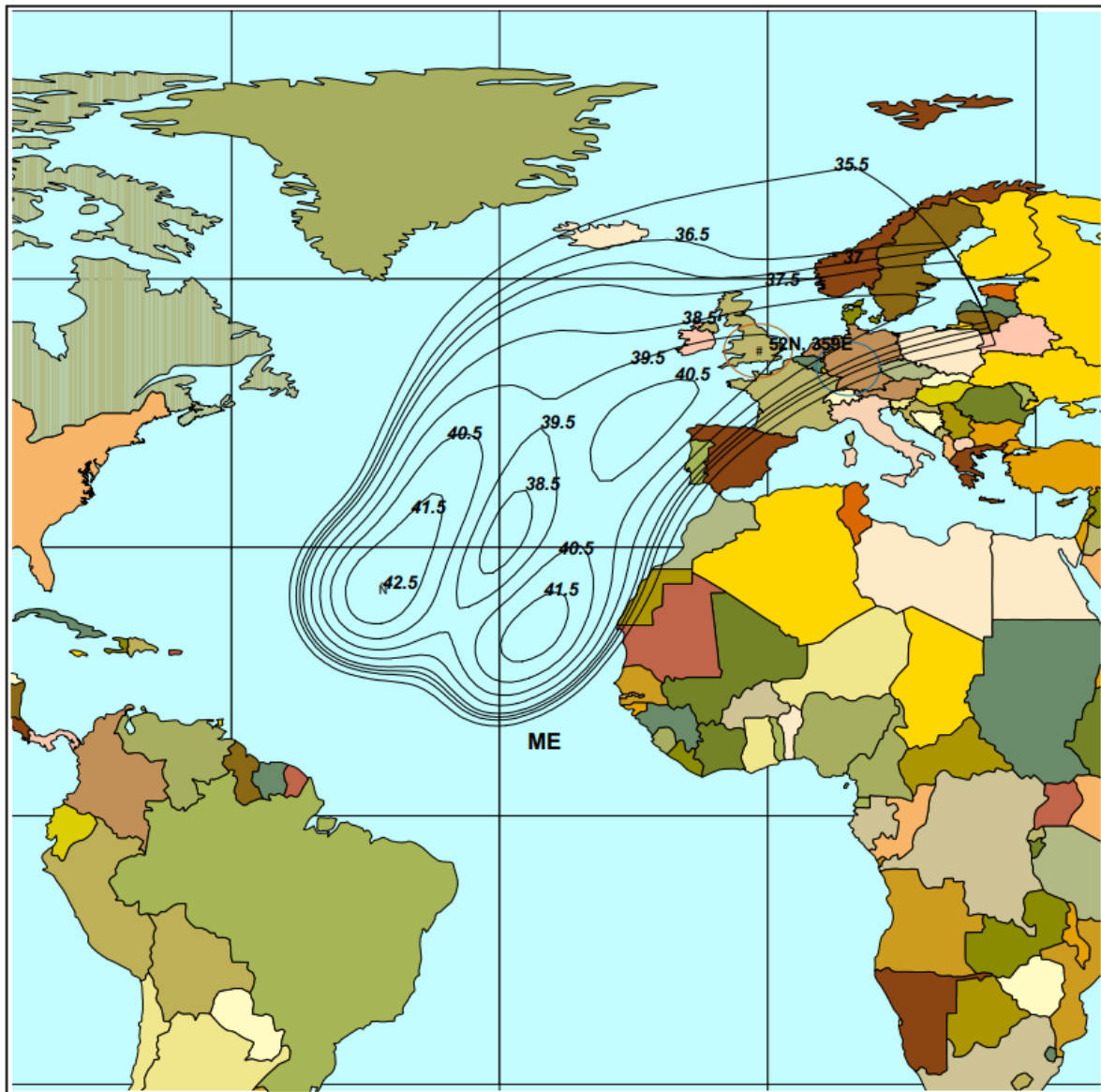
Combined East Zone Beam Coverage



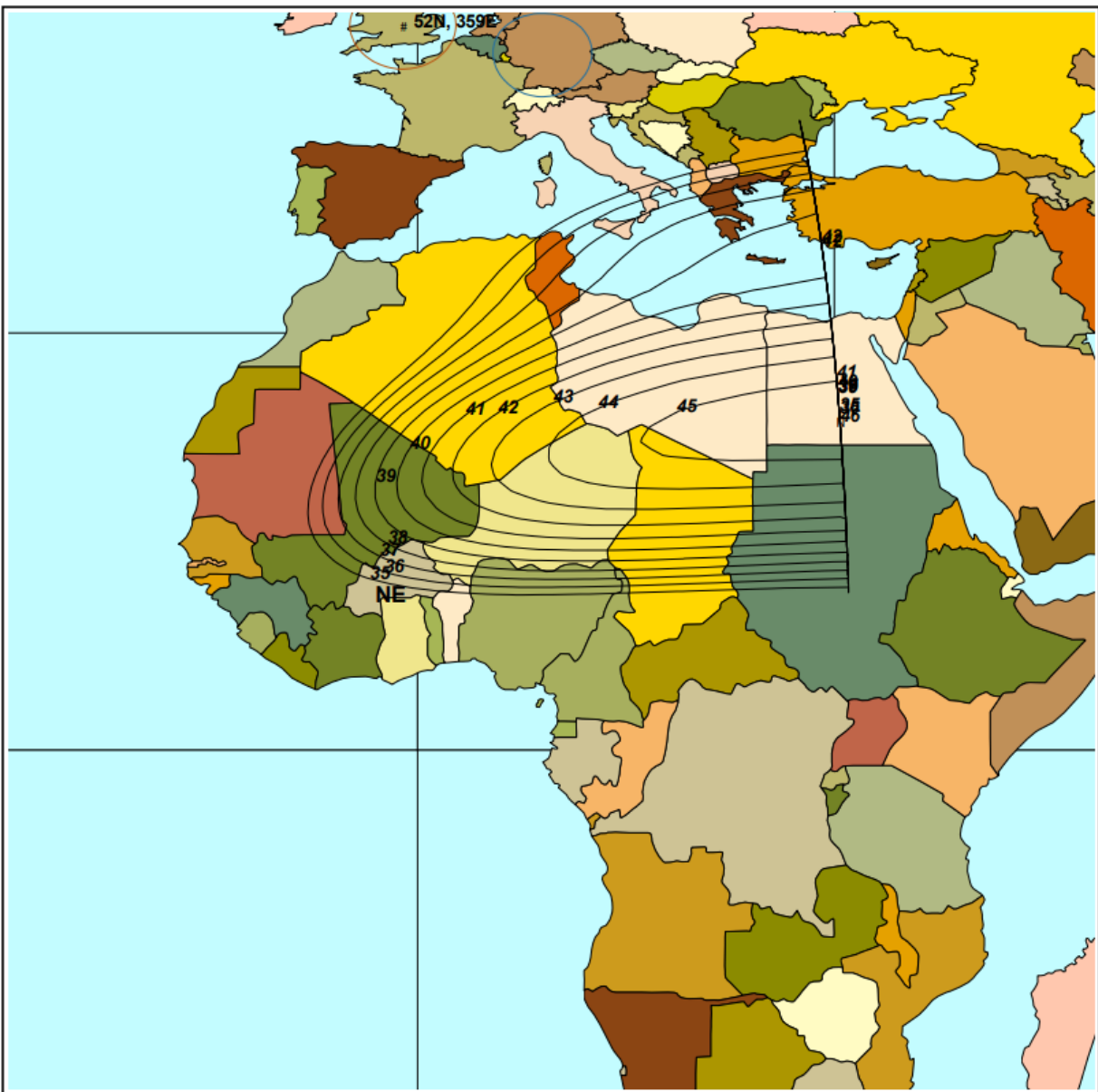
East Hemi Beam Coverage



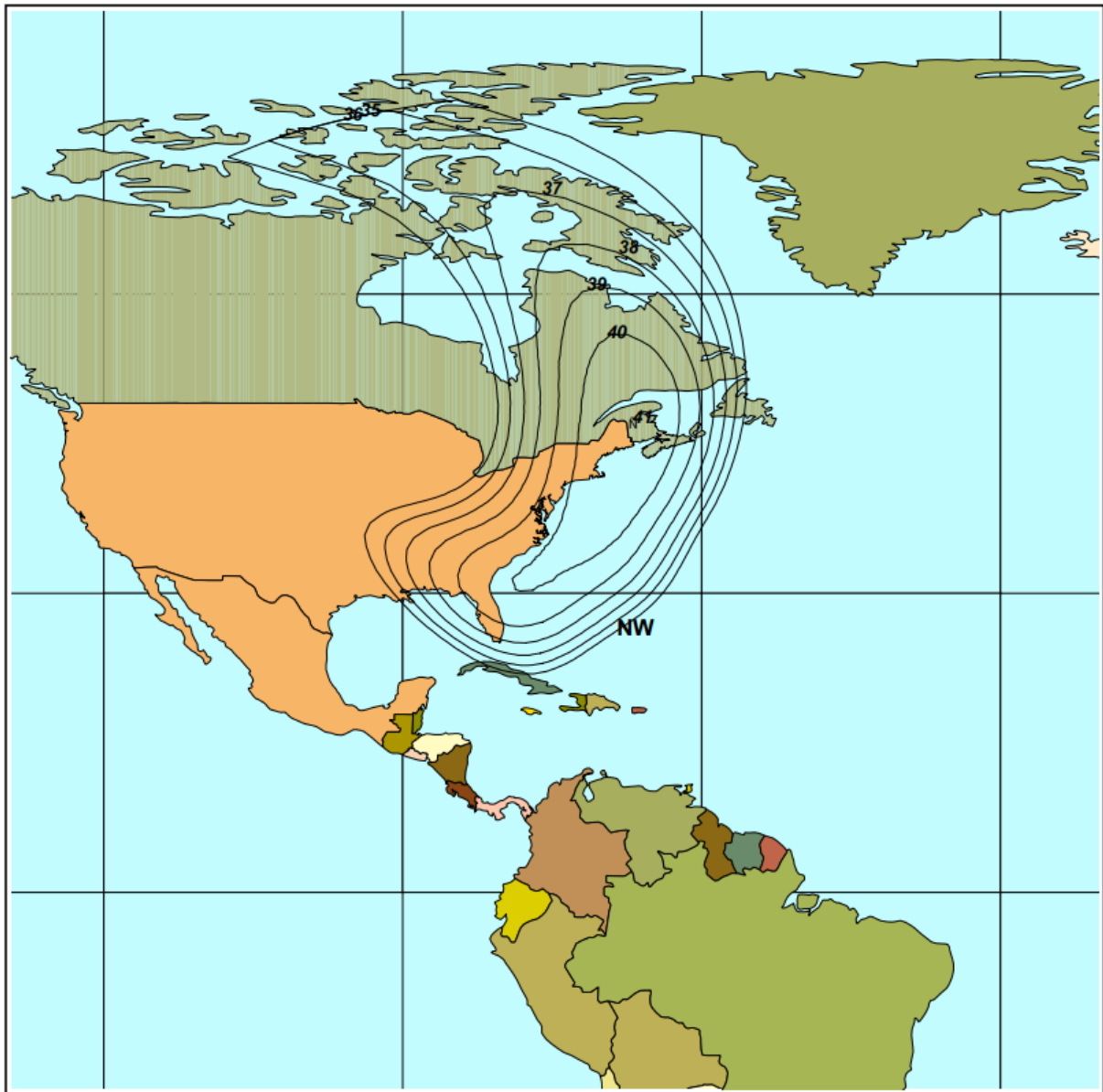
Mideast Zone Beam Coverage



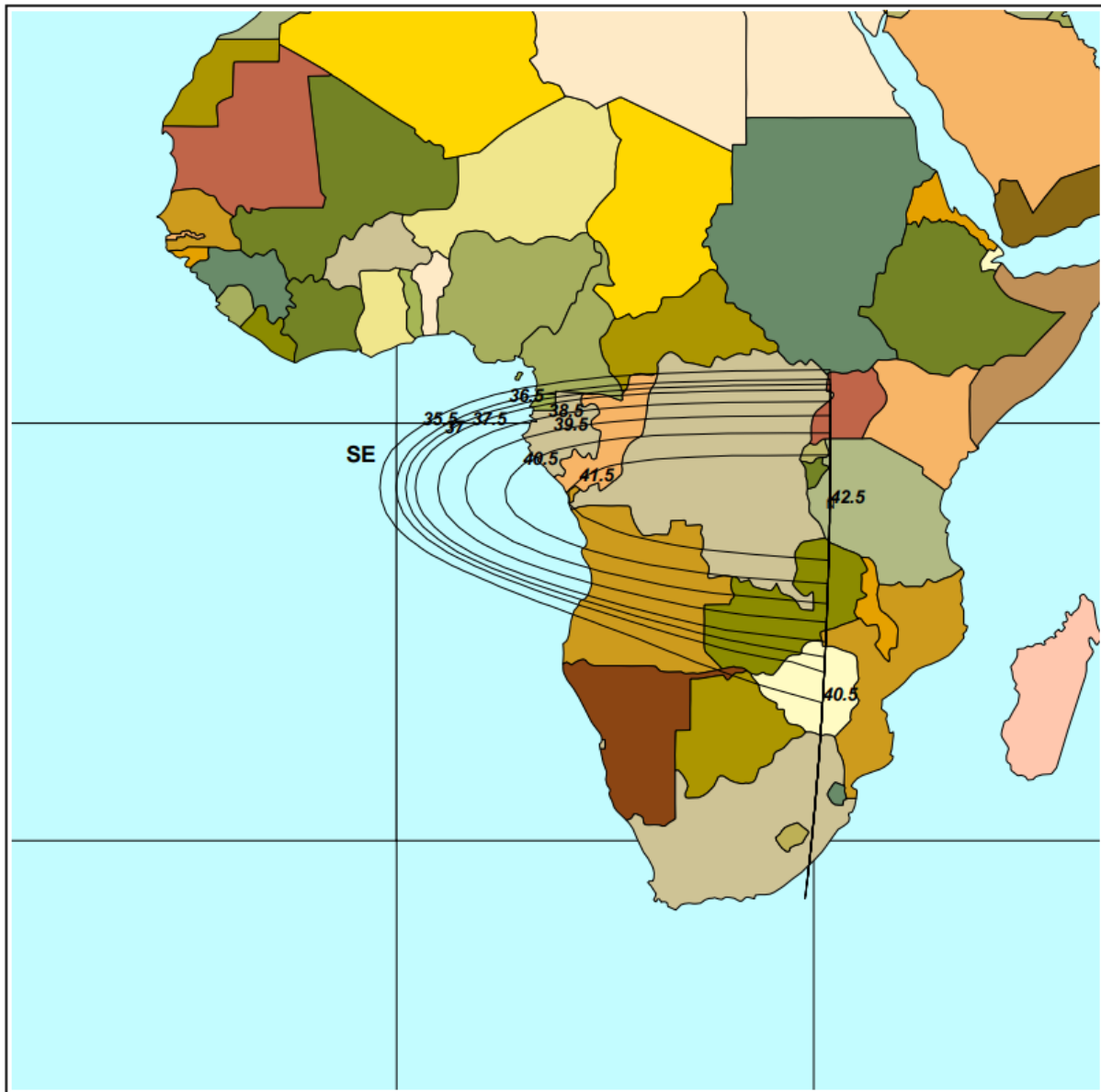
Northeast Zone Beam Coverage



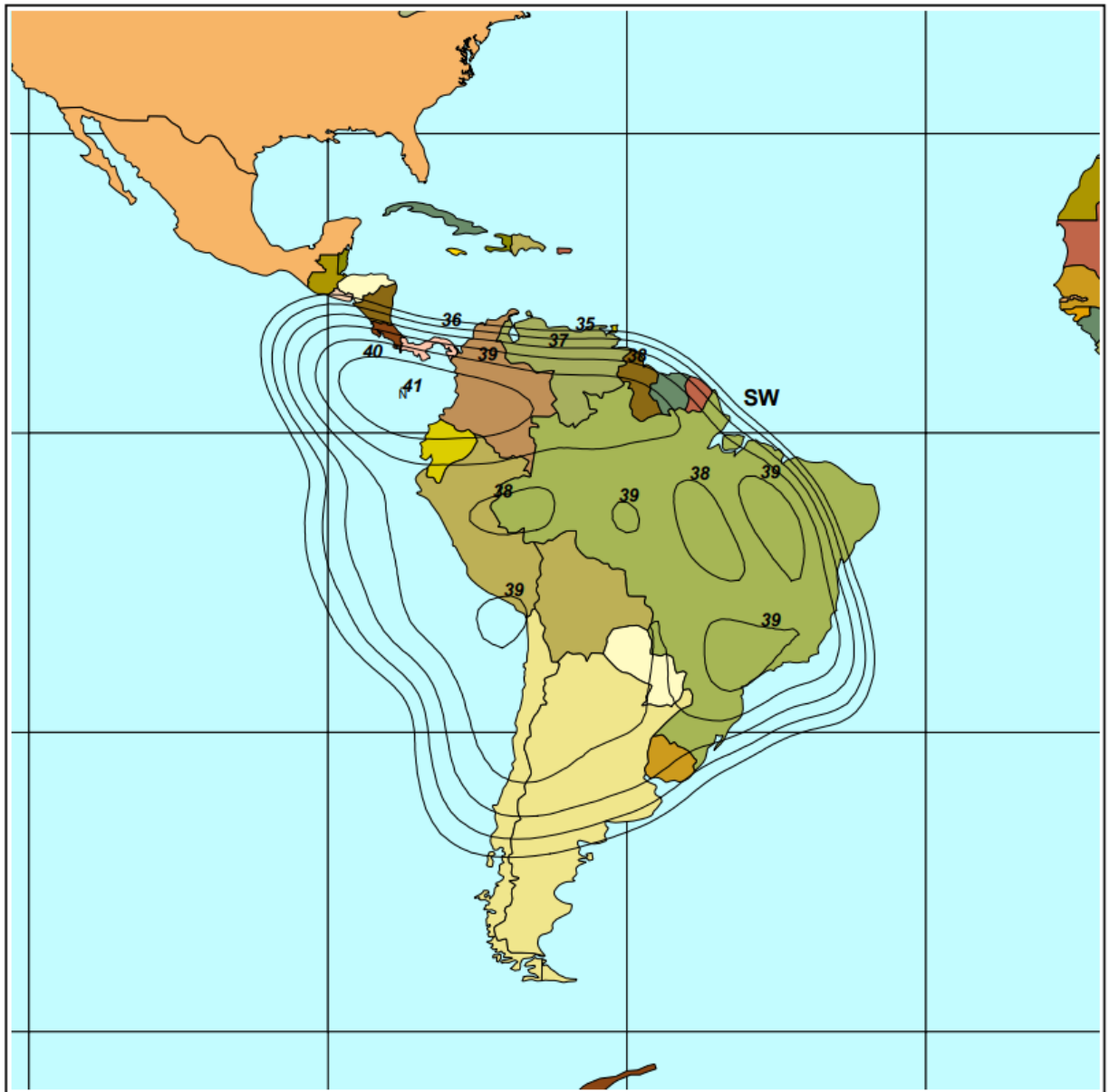
Northwest Zone Beam Coverage
