DG Consents Sub, Inc. ("DG Licensee") is a wholly-owned subsidiary of DigitalGlobe, Inc. ("DigitalGlobe"), a Delaware corporation. Upon consummation of the proposed transaction, DigitalGlobe will become a wholly-owned subsidiary of SSL MDA Holdings, Inc. ("SSL MDA Holdings"), a Delaware corporation and itself a wholly-owned subsidiary of MacDonald, Dettwiler and Associates Ltd. ("MDA"), a publicly-traded corporation organized under the laws of British Columbia, Canada. The Applicants provide an organizational chart as an appendix to this exhibit.

<u>Ownership</u>

After consummation of the transaction, no individuals or entities will hold a 10 percent or more equity and/or voting interest in MDA.

Directors

Upon consummation of the transaction, MDA will appoint three individuals as mutually agreed upon in good faith by DigitalGlobe and MDA (each of whom must have been serving as a director of the DigitalGlobe Board of Directors as of the date of the Merger Agreement) and reasonably approved by the Nominating and Governance Committee of the MDA Board of Directors to serve on the MDA Board of Directors (the "DG Designees"). In addition, SSL MDA will appoint two of the Company Designees as mutually agreed upon in good faith by DigitalGlobe and MDA to serve on the SSL MDA Board of Directors.¹
