## FCC Form 312, Questions 40 and A20

Michael Fuqua, Receiver, ("Receiver"), as appointed by the United States District Court for the Southern District of New York ("Court"), out of an abundance of caution, provides the below ownership information. As explained in the Narrative Exhibit attached to the instant application, on November 8, 2021, the Court issued an order appointing Receiver, which resulted in the involuntary transfer of control for which Commission consent is sought in the instant application. The Receivership Order, among other things, authorized Receiver to take control of all assets in the possession of, under the control of, or held in the name of Theia Group, Inc. d/b/a Thorian Group and/or Cypherian, Theia Aviation LLC, and Theia Holdings A, Inc. d/b/a Thorian Holdings (collectively, "Theia"). Receiver is a U.S. citizen, having a business address of 3445 Peachtree Rd, Suite 1225, Atlanta, GA 30326.

The ownership of stock conferring equity and/or voting interests in Theia, officers, and directors of Theia remain unchanged, but the affairs of Theia are now under the control of Receiver pursuant to the Receivership Order. As a result, notwithstanding that Receiver is in control of the affairs and assets of Theia as described above, out of an abundance of caution and to provide information responsive to the specific requests in Questions 40 and A20 of FCC Form 312 and Schedule A thereto, this exhibit provides below an overview of the ownership, officers, and directors of Theia that remain unchanged as a result of Receiver's appointment. In addition, Exhibit 1 provides an illustrative view of the control structure both before and after the appointment of Receiver.




## EXHIBIT 1
