The Americas-1 Consortium amends the above-referenced Application filed on March 26, 2019 (“Application”) as follows.


First, the interest in Americas-1 held by Sprint Communications Company L.P. (“Sprint”), a party to the Application, has been acquired by Atlantic Telecommunications Operating Company Limited (“ATOC”), which is a party to the Application. See Public Notice, DA 20-109, SCL-ASG-20190222-00006, Jan. 28, 2020. As the result of that transaction, ATOC held an interest in Americas-1 of 7.65%. As the result of further changes in the ownership of Americas-1 described in the letter dated July 10, 2020 and filed herewith, ATOC now holds an interest of 8.24782%. All other information stated in Appendix B to the Application and the amendments thereto remains correct.

Second, Sprint accordingly withdraws from the Application.

Third, on or around June 30, 2020, MCI International, Inc., which is a party to the Application, was converted to a limited liability company and became MCI International LLC. Also as a part of the same *pro forma* reorganization, MCI Communications Corporation, one of the wholly-owned corporate entities indirectly above MCI International in the ownership hierarchy, merged into its parent Verizon Business Global LLC, thus removing it from the chain of ownership described in the Appendix C of the Application and the amendments thereto. All other information stated in Appendix C to the Application and the amendments thereto remains correct.
