AMENDMENT TO APPLICATION

DigitalBridge Group, Inc. (“DigitalBridge” or “Transferor”); Zayo Group, LLC (“Zayo” or “Licensee”) and Duncan Holdco LLC (“Duncan” or “Transferee”) (collectively the “Applicants”) submit this Amendment to their Application for Authority to Transfer Indirect Control of Cable Landing License Authorization filed on April 21, 2026, to address comments from Commission staff regarding formatting issues and to update responses to certain questions on FCC Form 220 as identified below:

- **Question 19(a)** – The ownership disclosures in column (e) have been updated to reflect a single entity in which the interest holder has a direct interest, in lieu of multiple entities that the interest holder identified in column (a) controls. In addition, columns (f) and (g) have been updated to reflect the percentage of direct interest that the interest holder has in the entity identified in column (e).
- **Question 21(a)** – Each foreign carrier affiliate has been entered as a separate entity in lieu of multiple entities for a specific country. With this update there are a total of 38 foreign carrier affiliates referenced consistent with Exhibit C of the underlying application.
- **Question 31** – The response to the Executive Branch question has been updated to Yes.
