Pursuant to Section 1.767(g)(7) of the Commission's rules, AT&T Corp. ("AT&T"), on behalf of PT Telekomunikasi Indonesia, Tbk. ("Telkom Indonesia") and the other members of the Asia America Gateway ("AAG") Consortium, provides notification of the following *pro forma* assignment of the ownership and voting interests in the AAG cable system held by Telkom Indonesia.

Telkom Indonesia holds a greater than 5 percent interest in the AAG cable system and is a cable landing licensee for this system.¹ On July 20, 2010, the AAG Consortium approved the assignment of Telkom Indonesia's ownership and voting interests in the AAG cable system to Telkom Indonesia's direct subsidiary, PT Telekomunikasi Indonesia International ("TII"), a limited liability company established under the laws of the Republic of Indonesia. Telkom Indonesia holds 99.99 percent of the equity of TII.²




