Dear Ms. Dortch:

Pursuant to Section 1.767(g)(7) of the Commission's rules, AT&T Corp. ("AT&T"), on behalf of Datastream Technology Sdn Bhd ("DST"), Telekom Brunei Berhad ("Telbru"), and the Government of his Majesty the Sultan and Yang Di-Pertuan of Brunei Darussalam represented by the Ministry of Communications ("Government of Brunei") and the other members of the Asia America Gateway ("AAG") Consortium, provides notification of the following *pro forma* assignment of the ownership and voting interests in the AAG cable system held by DST, Telbru and the Government of Brunei.

DST, Telbru and the Government of Brunei hold a greater than 5 percent interest in the AAG cable system and are a cable landing licensee for this system.¹ The cable landing license states that DST and Telbru were the proposed shareholders for a special purpose vehicle being incorporated by Brunei Darussalam to assume the Government of Brunei's role in the AAG project.² Consistent with the disclosure of Brunei's proposed ownership structure of the submarine cable system in the AAG application, on July 20, 2010, the AAG Consortium approved the assignment of the ownership and voting interests in the AAG cable system held by his Majesty the Sultan and Yang Di-Pertuan of Brunei Darussalam represented by the Ministry of Communications to Brunei International Gateway Sdn Bhd ("BIG"), which was officially incorporated in Brunei on August 17, 2009. BIG is a joint venture company between the Government of Brunei through its investment vehicle, Brooketon Sendirian Berhad, and Telbru and DST International (b) Sdn Bhd, which is a wholly-owned subsidiary of DST.


