## SUPPLEMENT TO APPLICATION TO ASSIGN SPRINT'S INTEREST IN THE AMERICAS I CABLE SYSTEM TO ATOC

Atlantic Teleconnection Operating Company Limited ("ATOC"), pursuant to the Act Relating to the Landing and Operation of Submarine Cables in the United States, 47 U.S.C. §§ 34-39 (the "Cable Landing License Act"), Executive Order 10530, and Section 1.767 of the Commission's rules, 47 C.F.R. § 1.767, submits this supplement to the application filed February 22, 2019 requesting approval to assign the 6.95388 percent interest Sprint Communications Company L.P. holds in the Americas I Cable System to ATOC ("Application"). ATOC files this Supplement in response to a request from the International Bureau to certify its future compliance with the conditions of the Americas I Cable System 1993 authorization.

The Americas I Cable was authorized in 1993 and is therefore not subject to the routine conditions the Commission adopted for cable landing licensees in 2001.<sup>1</sup> ATOC certifies that it
