Re: Pro Forma Assignment of an Interest in the Havfrue Cable Landing License,

Dear Ms. Dortch:

Pursuant to 47 U.S.C. § 34, Executive Order No. 10,530, and 47 C.F.R. § 1.767(g)(7), the undersigned hereby notify the Commission of the *pro forma* assignment of an interest the cable landing license for the Havfrue submarine cable system, from America Europe Connect 2 Limited ("AEC2") (FRN 0027231869) to Aqua Comms (Americas) Inc. ("Aqua Comms Americas") (FRN 0029384567) in connection with the commissioning of the Havfrue system. The Commission originally licensed the Havfrue system on September 6, 2019, ¹ and the system entered commercial service on November 17, 2020.²

During the project development process for the Havfrue system, AEC2 held the voting and participation interests in the wet segment of the Havfrue system identified in the cable landing license application. Upon commercial acceptance of the system from the supplier and commencement of commercial operations on Havfrue, the U.S.-territory portion of those interests have been assigned from AEC2 to Aqua Comms Americas.³ This internal and *pro forma* reorganization will simplify and streamline the ownership of these assets. Please note that this reorganization does not affect the activities or assets of America Europe Connect 2 USA Inc. ("AEC2 USA"), which will remain as the U.S. landing party for Havfrue and a joint cable landing licensee for the system.

AEC2 has also assigned those interests in international waters and Irish territory to Aqua Comms (Ireland) Limited and those interests in Danish territorial waters to Aqua Comms (Denmark) ApS. Neither Aqua Comms (Ireland) Limited nor Aqua Comms (Denmark) ApS uses the U.S. endpoint of Havfrue or is required to be a licensee under 47 C.F.R. § 1.767(h).
