Re: Pro Forma Assignment of an Interest in the Havfrue Cable Landing License, File Nos. SCL-LIC-20180511-00010 and SCL-ASG-20201130-00047

Dear Ms. Dortch:

This letter supplements the notice filed by Aqua Comms (Americas) Inc. ("Aqua Comms Americas") regarding the *pro forma* assignment of an interest in the Havfrue cable landing license¹ from America Europe Connect 2 Limited ("AEC2") to Aqua Comms Americas.

AEC2 is a party to the supply contract with the Havfrue system supplier, SubCom, LLC ("SubCom"). To simplify and streamline its operations, AEC2 executed (along with the other Havfrue owners) a Certificate of Commercial Acceptance with SubCom, effective November 12, 2020, providing among other things that Aqua Comms Americas would take title to the U.S.-territory portion of AEC2's interest in the Havfrue system(the "*Pro Forma* Transaction"). The *Pro Forma* Transaction did not result in a change in ownership of entities, but only of certain assets. Pre- and post-consummation, all of the asset-owning entities have remained wholly-owned, direct or indirect subsidiaries of Aqua Comms Designated Activity Company and ultimately controlled by the 2013 Bake Family Trust.

As noted in its November 30, 2020 notification to the Commission, Aqua Comms Americas is already a cable landing licensee for the AEC-1 submarine cable system.² The attached Appendix 1 and Attachments 1 through 3 show the ownership of Aqua Comms Americas.

Pursuant to 47 C.F.R. § 1.767(a)(9), Aqua Comms Americas agrees to accept, and will abide by, the routine conditions in 47 C.F.R. § 1.767(g).






