Dear Ms. Dortch:

As requested by Commission staff, Globenet Cabos Sumarinos America, Inc. f/k/a Brasil Telecom of America, Inc. (“Licensee”)¹ hereby submits this letter to re-notify the Commission that the GlobeNet-Atlantica-1 submarine cable system entered into service as follows: (i) Segment 4 (Bermuda to Fortaleza, Brazil) on September 30, 2000; and (ii) segments servicing the United States (*i.e.*, Segment 1 (Tuckerton, NJ to Boca Raton, FL) and Segment 2 (Boca Raton, FL to Maiquetia, Venezuela)) on March 28, 2001. Subsequent segments of the GlobeNet system entered into service at later dates. The basis of the in-service dates is Licensee’s own ready for service records. A confidential copy of the service records (“In-Service Letter Exhibit”) is being submitted to the Secretary in paper format by hand, along with a request for confidential treatment.

Licensee searched its records for a copy of the original in-service letter to the Commission so that it might be electronically uploaded to IBFS. However, given Licensee’s personnel changes in the last 18 years, it has not been able to locate the original in-service letter to the Commission and is therefore providing this letter pursuant to FCC staff’s request.
